

Advertisement and Invitation for Bids

The City of Devine will receive bids for Water Transmission Line until 11:00 a.m. on April 6, 2022 at 303 South Teel, Devine TX 78016 at which time the bids will be publicly opened and read aloud.

Bids are invited for several items and quantities of work as follows:

Base Bid: 934 LF of 12 inch PVC Water Main, 4 EA Gate Valves & Boxes, 1.21 Tons DI Fittings, 25 LF Saw Cut Remove and Replace Existing Asphalt Pavement, 24 LF Remove and Replace Existing Gravel Driveways, 2 EA Interconnections, 1 EA Testing and Disinfection.

Additive Alternate Bid: 4,204 LF of 12 inch PVC Water Main, 6 EA Gate Valves & Boxes, 1 EA Air Release Valves, 2.39 Tons DI Fittings, 115 LF Saw Cut Remove and Replace Existing Asphalt Pavement, 105 LF Remove and Replace Existing Gravel Driveways, 1 EA Interconnections, 1 EA Testing and Disinfection.

Bid/Contract Documents, including Drawings and Technical Specifications are on file at Garcia & Wright Consulting Engineers, Inc., 407 W. Rhapsody, San Antonio, TX 78216 and 303 South Teel, Devine TX 78016 at which specifications can be obtained.

Copies of the Bid/Contract Documents may be obtained by depositing \$ 100.00 with the Engineer for each set of documents obtained. The deposit will be refunded if the documents and drawings are returned in good condition within 10 days following the bid opening.

A bid bond in the amount of 5 percent of the bid issued by an acceptable surety shall be submitted with each bid [for those contracts that exceed \$100,000]. A certified check or bank draft payable to the City of Devine or negotiable U.S. Government Bonds (as par value) may be submitted in lieu of the Bid Bond. Attention is called to the fact that not less than, the federally determined prevailing (Davis-Bacon and Related Acts) wage rate, as issued by the Texas Department of Agriculture Office of Rural Affairs and contained in the contract documents, must be paid on this project. In addition, the successful bidder must ensure that employees and applicants for employment are not discriminated against because of race, color, religion, sex, sexual identity, gender identity, or national origin. The City of Devine reserves the right to reject any or all bids or to waive any informalities in the bidding.

Bids may be held by City of Devine for a period not to exceed 30 days from the date of the bid opening for the purpose of reviewing the bids and investigating the bidder's qualifications prior to the contract award.
