Notice is hereby given that an Emergency Meeting of the City Council of the City of Devine will be held on **February 2, 2023, beginning at 5:15 pm** at the Dr. George S. Woods Community Center, 200 E. Hondo Avenue, Devine, Texas.

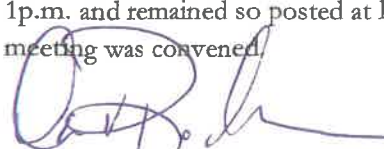
THE EMERGENCY MEETING IS REQUIRED DUE TO THE BAIN WELL HAVING A LEAK THAT WILL REQUIRE PUBLIC WORKS TO DETERMINE HOW MANY CUSTOMERS WILL HAVE THEIR WATER TEMPORARILY SHUT OFF TO ASSESS THE REQUIRED REPAIRS AND TO MAKE THE REQUIRED REPAIRS. IN ADDITION, THE WARHORSE DRIVE GROUND STORAGE TANK HAS EXCEEDED ITS LIFE EXPECTANCY AND NEEDS TO BE REPLACED. THIS ITEM WILL POTENTIALLY HAVE AN IMMEDIATE EFFECT UPON THE DRINKING WATER OF THE CITIZENS OF DEVINE

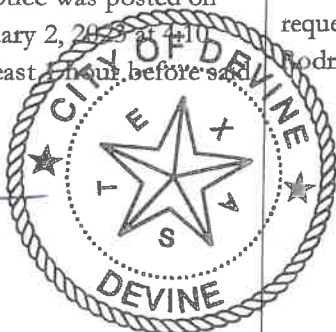
The subjects to be discussed or considered or upon which any formal action may be taken are as follows:

2. Discuss and consider the Bain Well – Leak repair and testing of valves.
3. Discuss and consider the Ground Storage Tank on Warhorse – Replacing the Storage Tank due to companies not able to do repairs needed due to the age of the Tank.
4. Adjourn.
