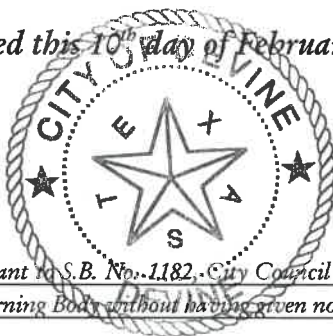
NOTICE OF A SPECIAL LIVE STREAM MEETING OF THE DEVINE CITY COUNCIL.

Notice is hereby given that a *Special Meeting* of the governing body of the City of Devine will be held on the **13th day of February, 2023 at 6:00 p.m.** at the Dr. George S. Woods Community Center, 200 E. Hondo Avenue, Devine, Texas at which time the following subjects will be discussed, considered or action taken:

1. Call to Order.
2. Discuss and consider Ordering a City General Election to be held on May 6, 2023 for Mayor, and One (1) Alderman for District #2 and District #5, and a Bond Election. (*Discutir y considerar ordenar una Elección General de la Ciudad que se llevará acabo el dia 6 de Mayo del 2023 con el propósito de elegir un Alcalde, y un (1) Concejal para los Distritos #2 y #5, y una elección de bonos.*)
3. Discuss and consider accepting Notice of Election. (*Discutir y considerar aceptar la Noticia de Elección.*)
4. Discuss and consider adopting an ordinance calling a bond election to be held in the City of Devine, Texas; making provision for the conduct of the election; and resolving other matters related to such election. (*Discutir y considerar la adopción de una ordenanza para convocar una elección de bonos que se llevará a cabo en la ciudad de Devine, Texas; tomar disposiciones para conducir la elección; y resolver otros asuntos relacionados con dicha elección.*)
5. Discuss and consider how the bonds should be sold if the voters approve the issuance of the drainage bonds. (*Discutir y considerar cómo vender los bonos si los votantes aprueban la emisión de los bonos de drenaje.*)
6. Adjourn.
