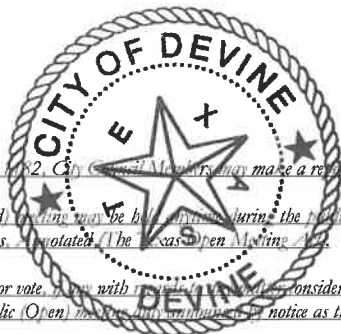
1. Call to Order.
2. Discuss and take any necessary action on Resolution authorizing the submission of an application, to include the Civil Rights policies, for the 2023-2024 TxCDBG Community Development Fund competition for a water improvement project.
3. Discuss and take any necessary action on Resolution authorizing the submission of an application, to include the Civil Rights policies, for the 2023-2024 TxCDBG Community Development Fund competition for a sewer improvement project.
4. Discuss and take any necessary action on Resolution authorizing signatories for the 2023-24 application and future grants administered through Texas Department of Agriculture TDA Go grants online.
5. Consider and act upon granting a 10 foot easement to Yancey Water Supply on the north side of the Devine Municipal Airport, on FM 2200.
6. Public Hearing on a Bond Election as follows:
Proposition A – The issuance of not to exceed \$15,020,000 of the City of Devine, Texas General Obligation Bonds for Drainage and Flood Control Improvements and the levying of a tax in payment.
