

ORDINANCE NO. 9B-2025

AN ORDINANCE BY THE CITY OF DEVINE, TEXAS APPROVING AND ADOPTING A BUDGET FOR THE FISCAL YEAR BEGINNING ON OCTOBER 1, 2025 IN THE TOTAL AMOUNT OF \$9,958,858.

Whereas a proposed budget for operating the municipal government of the City of Devine, Texas was submitted to City Council in accordance with Texas Local Government Code § 102.006.

Whereas public hearings on the budget for the City of Devine for Fiscal Year 2025-2026 were held on numerous dates, with a final public hearing on the budget being held on September 29, 2025; and

Whereas the City Council finds that after full consideration of proposed expenditures, revenues, financial condition, and comparative expenditures was presented, the budget as finally considered at said final hearing shall be approved and adopted;

Now therefore, be it ordained by the City Council of the City of Devine, Texas:

1. The City Council of the City of Devine, Texas officially closed all public hearings in regard to the following budget, and approves and adopts the budget for the City of Devine's 2025-2026 Fiscal Year in the total amount of \$9,958,858, which is posted in detail online at <https://cityofdevine.org> and incorporated herein for all purposes, and which is described in general in "Exhibit A" attached hereto and incorporated herein for all purposes;
2. The appropriations for the 2025-2026 fiscal year for the different administrative units and purposes of the City of Devine, Texas are fixed and determined for said fiscal year in accordance with the expenditures shown in said budget, and the distribution and division of said appropriations shall be made in accordance with said budget including such amounts shown for providing for sinking funds for the payments of the principal and interest and the retirement of the bonded debt of the City of Devine.
3. An original copy of the City of Devine's 2025-2026 Fiscal Year Budget described above as "Exhibit A" shall be available for public inspection in the office of the City Secretary and the Medina County Clerk as provided by state law.
4. All ordinances and appropriations or parts of ordinances and appropriations in conflict with this ordinance are repealed to the extent of such conflict.
5. If any provision of this ordinance, or the application thereof to any person or circumstances, shall be held invalid or unconstitutional by a court of competent jurisdiction, such invalidity shall not affect the other provisions, or application thereof, of this ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared to be severable.

6. The provisions of this ordinance shall become effective immediately upon final passage and approval by the City Council of the City of Devine, Texas.
