1. Proposed budget for Fiscal Year 2026-2027.

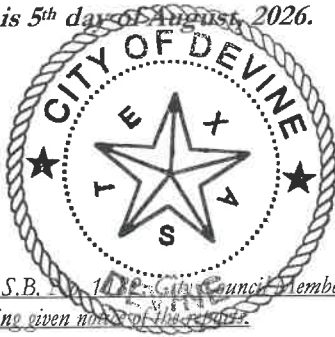
